Ammonium hydroxide (1336-21-6) 8-10%, water (7732-18-5) 90-92%

White cloudy liquid with strong ammonia odor.

Mildly toxic by ingestion and inhalation. Irritating to body tissues. Lachrymator.

Avoid all body tissue contact.

SECTION 4 — FIRST AID MEASURES

Call a physician and seek medical attention for further treatment, observation, and support after first aid.

Inhalation: Remove to fresh air at once. If breathing has stopped, give artificial respiration immediately.

Eye: Immediately flush with fresh water for at least 15 minutes.

External: Wash continuously with fresh water for at least 15 minutes.

Internal: Give large quantities of water. Call a physician or poison control at once.

Nonflammable, noncombustible.

When heated to decomposition, emits toxic fumes of NH₃ and NOx.

Fire Fighting Instructions: Use a triclass, dry chemical fire extinguisher. Firefighters should wear PPE and SCBA with full facepiece operated in positive pressure mode.

Flinn Suggested Chemical Storage Pattern: Inorganic #4. Store in a dedicated base cabinet. If a cabinet is not available, store in a Flinn Saf-Cube.

Use and dispense in a hood.

Avoid contact with eyes, skin, and clothing. Wear chemical splash goggles, chemical-resistant gloves, and chemical-resistant apron. Use exhaust ventilation to keep airborne concentrations low.
