Emergency overview

Potential acute health effects

4. First aid measures

In case of inhalation of decomposition products in a fire, symptoms may be delayed. The exposed person may need to be kept under medical surveillance for 48 hours.

5. Fire-fighting measures

Flammability of the product

: Fammable liquid. In a fire or if heated, a pressure increase will occur and the container may burst, with the risk of a subsequent explosion. Vapors may accumulate in low or confined areas or travel a considerable distance to a source of ignition and flash back. Runoff to sewer may create fire or explosion hazard.

Extinguishing media

Suitable

: Use dry chemical, CO₂, water spray (fog) or foam.

Special exposure hazards

: Do not use water jet.

6. Accidental release measures

Personal precautions

Large spill

Contain and collect spillage with noncombustible, absorbent material e.g. sand, earth, vermiculite or diatomaceous earth and place in container for disposal according to local regulations (see Section 13). Handling and storage 7.

Handling

: Materials such as cleaning rags, paper wipes and protective clothing, which are contaminated with the product may spontaneously self-ignite. To avoid the risks of fires, all contaminated materials should be placed in a metal container filled with water and sealed. Contaminated materials should be removed from the workplace at the end of each working day and be stored outside. Put on appropriate personal protective equipment (see Section 8). Storage

Hands
