Emergency and First Aid Procedures

Do not direct a water stream directly into the hot burning liquid.

Section 6 Spill or Leak Procedures

Steps to Take in Case Material Is Released or Spilled: Exposure to the spilled material may be irritating or harmful. Follow personal protective equipment recommendations found in Section 8 of this SDS. Additional precautions may be necessary based on special circumstances created by the spill including; the material spilled, the quantity of the spill, the area in which the spill occurred. Also consider the expertise of employees in the area responding to the spill. Isolate area. Keep unnecessary personnel away. Remove soiled clothing and launder before reuse. Surfaces may become slippery after spillage.

Use an inert absorbent such as sand or vermiculite. Place in properly labeled closed container. Contain the discharged material.
